Meaning of Doctrine of Ultra Vires. The doctrine of ultra vires applies to the memorandum of association of a company. The memorandum of association contains the permitted range of activities in its objects clause and a company cannot practice any other activity which is not defined under the scope of objectives mentioned in the memorandum. Any activity done out of the purview of the memorandum is considered as an ultra vires activity.

Doctrine of ultra vires At common law, true of the consequences of the incorporation of a company is that the power of the company is limited to carrying into effect the business or object for which it is incorporated.
